### RICE FOR REFUGEES

Mizoram raltlan awm mek mi 40,000 velte tanpuina atana a thlawna buhfai sem tur chu phurhluh zawh tep a ni.

Food, civil supplies & consumer affairs (FCS&CA) department hotute hnen atanga thu dawn danin sorkar laipui ruahmannna anga buhfai metric tonne 1,379 leh quintal 34 phurh luh hna hi zawh fel a ni tep tawh a. Tun kar chhung hian phurh luh zawh hman beisei a ni. Food corporation of India (FCI)-in pekchhuah phalna (release order) a tihchhuah mai loh avangin buhfai phurh hna hi an tan tlai a. Chuti chung chuan phalna hmuh ve leh atangin phurh luh nghal a ni a. Tun kar hi chuan zawhfel vek tum a ni. Buhfai hi district hmunpui thlenpui a, kudam a dah nghal zel a ni a. FCS&CA director chuan tunkar chhung hi chuan phurh zawh fel vek hman an inrin thu Akashvani Aizawl a hrilh a. Hemi hnu lamah chuan home department ruahmannna-in district 11 a bawrhsap pisa a hnathawkte'n a sem hna an buaipui zui dawn a ni.

MSPMC-in hna hrang hrang a endik tawh 31 zingah hian central sorkar project 22, cheng vaibelchhe 419 leh nuai 7 hu, state sorkar hnuai a thawh project 5, cheng vaibelchhe 65 leh nuai 32 hu bakah hna 4, cheng vaibelchhe 735 leh nuai 81 hu chu central leh state sum hmanga project thawhte a ni a. Hna 31 thawhna atana sum ruahman hi a vai chuan cheng vaibelchhe 1,220 leh nuai 20 a ni. MSPMC-in an endik tawh zinga Project thenkhat, hna tha lo leh a nih tur ang pha lo te chu siam thattir mai bakah Department a endikna a mawhphurtute chunga dan anga action la tura thurawn pek te pawh a awm bawk niin tun hnai a MSPMC hmalakna tlangpui thlirletna tihchhuahah tarlan a ni a. leng avanga vawk thi an chhinchhiah tan atangin vawk 14,699 a thi tawh a. Tun
