The central government has projected capital expenditure target of 11.21 lakh crore rupees in the Union Budget for the financial year 2025-26 reinforcing its commitment to infrastructure-driven growth. The government has allocated record 6 lakh 81 thousand crore rupees for defense, which is an increase of 9.53 percent from the current financial year. Railways and Information and Broadcasting Minister Ashwini Vaishnaw said that the Union Budget 2025 has laid the roadmap for Viksit Bharat. Mr Vaishnaw said the capital expenditure for railways is huge, with a Gross Budgetary Support of over 2.52 lakh crores.



The overall budget allocation for the development of Scheduled Tribes has jumped by 45.79 percent to 14,925.81 crore rupees in 2025-26 from

10,237.33 crore rupees the previous year. Key measures proposed by the Union Budget 2025-26 include expansion of Pradhan Mantri Adi Adarsh Gram Yojana by 163 percent to 335.97 crore rupees, focusing on bridging infrastructural gaps in education, healthcare, and employment. The outlay for Eklavya Model Residential Schools has nearly doubled to 7,088.60 crore rupees from last year to provide quality education to tribal students in remote areas. Meanwhile, allocation under the Pradhan Mantri Jan Jatiya Vikas Mission, has more than doubled to 380.40 crore rupees.



Over 1.95 lakh crore rupees in Gross Goods and Services Tax (GST) revenue was collected in the month of January 2025, witnessing a growth of 12.3 percent compared to January 2024. The Central GST collection for the month stood at 36 thousand 77 crore rupees and State GST is at 44,942 crore rupees. The Integrated GST collection amounts to over 1 lakh crore rupees and cess is at 13,412 crores. The highest growth of 39 percent was registered in Ladakh, followed by Nagaland and the Andaman and Nicobar Islands, which saw a 26 percent increase in GST.



Manipur and Nagaland are the highest GST-reliant states in the country, according to the Economic Survey Report 2024-25. During the period from April to November 2024, Manipur generated 78 percent of its revenue receipts from Goods and Services Tax (GST), followed closely by Nagaland with 72 percent, the survey said. Meanwhile, Odisha exhibited the highest share of non-tax revenue in its resource receipts at 49 percent. Maharashtra, Tamil Nadu, and West Bengal were the top contributors in stamps and registration, sales tax, and state excise duties, respectively.

Chief Minister Neiphiu Rio has called for promoting responsible tourism. The Chief Minister, who was on a visit to Mimi village in Kiphire near the Indo-Myanmar border, said this in a social media post yesterday. Highlighting the historical importance of Mimi known for its limestone caves and natural beauty, he urged for preserving its heritage. In Kiphire, Mr Rio also reviewed the Lower Tizu Hydro Electric Project and interacted with stakeholders. The Chief Minster was accompanied by several legislators and other officials.



The Supreme Court is scheduled to hear tomorrow a plea seeking implementation of specific guidelines and regulations to ensure safety of devotees attending the Maha Kumbh where at least 30 people were killed and 60 injured in a stampede on Wednesday this week. The petition seeks to prevent stampede incidents and protect the fundamental rights of equality and life under Article 21 of the Constitution. Among others, the plea has sought a direction to all states to establish facilitation centres at Prayagraj to provide safety information and assist their respective residents in emergencies. The plea also sought regulation of VIP movement and said public safety should be given priority over VIP protocols.



UN General Assembly President Philemon Yang has said that India has experienced remarkable transformation in the last decade. Yang said, during his visit to India from 4 to 8 of this month, he will get an opportunity to see how digital and technological innovation has fuelled this change, all the way to the grassroots level. Talking to media, he said as the world's largest democracy, the fifth-largest economy and home to one-fifth of humanity, India is an important member of the United Nations. Mr Yang said he looks forward to understand, more deeply, India's priorities and vision for the future of multilateralism.



Union Sports Minister Dr Mansukh Mandaviya today led Fit India 'Sundays On Cycle' initiative with the theme 'Obesity Free India' in

New Delhi. Addressing the event, the Minister emphasized on the importance of exercising and playing sports in the fight against obesity.

Dr Mansukh Mandaviya called for adopting a healthy lifestyle and reducing use of oil in food, to aid in overcoming the problem.



Cricketer Neizekho Rüpreo from Nagaland was awarded the MA Chidambaram Trophy for highest wicket-taker in the under-23 CK Nayudu Trophy (Plate Group) at the BCCI Awards 2025. Mr Rüpreo finished the CK Nayudu under-23 Tournament for the 2023-24 season with a total of 47 wickets. Meanwhile, Hem Chetri, also from Nagaland, won the MA Chidambaram trophy for highest run getter in the CK Nayudu trophy (Plate Group). The awards were presented yesterday in Mumbai. Secretary, Nagaland Cricket Association, Hyunilo Khing, received the award on behalf of Mr Rüpreo. Terming it as a proud moment for the association, Mr Khing said this recognition by the BCCI speaks volumes on cricket and sports as the next big profession for the youths of the state.



Nagaland is unlikely to see any rainfall activity over the coming week. India Meteorological Department has predicted dry spell over Nagaland and the adjoining states during the period. It said, wet spell is likely to continue over Western Himalayan Region till the 5th of February and likely over adjoining plains of Northwest India tomorrow. The weather body also forecast dense to very dense fog to continue over North India during next 24 hours and reduce in intensity thereafter.
