Nagaland government will be setting up a Solar Mission Team at the Directorate Level and a Solar Mission Cell at the Secretariat level to oversee the implementation of the PM Surya Ghar Muft Bijli Yojana, which is designed to facilitate the installation of rooftop solar panels in residential households across Nagaland. This was initiated during the first meeting of the Nagaland Solar Mission held under the Chairmanship of the Chief Secretary Dr. J Alam yesterday in Kohima. The meeting was attended by Finance Commissioner, Secretary Power, Engineer in Chief, Power and other Officials from the Power Department. The scheme approved by the Union Cabinet on 29th February 2024, aims to provide free electricity up to 300 units per month for one crore households by installing rooftop solar systems. Under the scheme, eligible households will receive substantial subsidies for installing rooftop solar systems (RTS). We have a report:

## **SOLAR SOUND BYTE:**

The central Government has announced subsidies ranging from 60 percent to 54 percent for 1KW to 3KW systems, respectively. To further support the national green energy transition, the Nagaland State Government will provide additional subsidies, reducing the cost burden for residents. State subsidies will range from 36 percent to 31 percent for RTS systems between 1KW to 3KW. For the financial year 2025-26, the State Government has allocated 10 crore rupees to assist with the implementation. As a result, the total subsidy for rooftop solar installation will reach up to 96 percent for systems up to 2KW and 85 percent for systems up to 3KW, enabling solar energy more accessible and affordable for the people of Nagaland.



A five-day State Curriculum Framework for School Education (SCF-SE) Integration Workshop got underway in Kohima, with participation from stakeholders including the State Council of Educational Research and Training, Directorate of School Education, District Institute of Education and Training and partners from Azim Premji University. During the inaugural event yesterday, Additional

Director, SCERT Nagaland, T. Lima Longkumer, highlighted that the development of curriculum frameworks at both the national and state levels is a key step in implementing the National Education Policy (NEP) 2020. Mr Longkumer emphasized that the workshop's goal is to integrate various sections developed by task groups into a unified, coherent document—the final State Curriculum Framework for School Education. He also stressed the importance of ensuring alignment in language, structure, and vision, while addressing the unique educational needs of Nagaland.



The Naga People's Front (NPF) Central Team held a consultative meeting with its Kohima Division yesterday at the NPF Central Office. The meeting, attended by senior party leaders and members, focused on strengthening the party's foundation and confirming its regional identity. In his keynote address, NPF Secretary General and MLA Achumbemo Kikon emphasized the party's core values, adding that while the NPF is in alliance with other political parties in the state government, its fundamental principles remain unchanged.
