Chief Minister Neiphiu Rio will present the State Budget 2025-26 on the State Legislative Assembly today. Mr Rio, who also holds the Finance Portfolio, will present supplementary demand for grants for 2024-25. Today, beside the Question hour, the house is schedule to take up Matters of Urgent Public Importance to discuss the issue pertaining to Mushrooming of Union & Associations in Nagaland. Meanwhile, two bills -The Nagaland Town and Country Planning (Fourth Amendment) Bill, 2025 and the Investment and Development Authority of Nagaland (Validation) Bill, 2025 introduced on March 4 will also be passed. The day's business also include laying of Annual Administrative Reports of 14 departments, laying of Reports/Rules and introduction of government bills, among others.

A review meeting was held under the Chairmanship of Deputy Chief Minister T.R. Zeliang, Minister Incharge of Planning & Transformation and National Highway to assess the progress of ongoing National Highway projects and address critical issues hindering their smooth implementation. During the review meeting, unresolved issues pertains to the land acquisition for the Peren-Dimapur (Package-V) and Kohima- Jessami (Package-II) were discussed. On the Kohima-Jessami (Package-II), Deputy Chief Minister directed the Contractor to commence work immediately, warning of termination for undue delays. Mr Zeliang reaffirmed the government's commitment to prioritizing the development of National Highways. While acknowledging the role of civil society as a watchdog, Mr Zeliang urged stakeholders to address grievances through proper channels rather than halting work. He emphasized that complaints regarding quality should be lodged with the District Administration or NHIDCL for verification. He assured that If claims are validated, appropriate action will be taken against the defaulting contractor. The Deputy Chief Minister also informed that he will conduct an onsite inspection of the Kohima Bypass on 11th of March to address minor issues faced by the contractor and NHIDCL, to ensure timely resolution of challenges and smooth progress of the project.
