The President stated this while inaugurating a National Conference on Environment-2025 at Vigyan Bhawan in New Delhi yesterday. The President added that environmental protection and its promotion will be possible only through continuous activism based on awareness and collective efforts of all.

Speaking on the occasion Union Minister of Environment, Forest and Climate Change, Bhupender Yadav said that India is focusing on ramping up innovations in low carbon technology.



The state Department of Health & Family Welfare has announced that starting April 1, Pradhan Mantri Jan Arogya Yojana and the Chief Minister Health Insurance Scheme will be operated in Trust Mode. In a circular, Chief Executive Officer of Nagaland Health Protection Society (NHPS), Thavaseelan K, informed all empanelled hospitals that, with the approval of the state government, NHPS will now directly manage the financial liabilities of both the schemes, without involving an insurance company. This means, NHPS will handle all claims and financial transactions through a Third-Party Administrator. The circular added that empanelled hospitals will continue to submit claims through the existing IT platform, now managed by NHPS, and the state government will be fully responsible for processing and disbursing claim payments. Further details on revised operational protocols, claim processing timelines, and grievance redressal mechanisms will be issued in due course.

An amount of 20.21 crore rupees was released to Nagaland under the Pradhan Mantri Matru Vandana Yojana (PMMVY) between financial year 2019-20 and 2024-25. During the period, 46,284 individuals from the state enrolled for the centrally sponsored maternity benefit scheme, Minister of State for Women and Child Development Savitri Thakur informed Lok Sabha on Friday. Of this, 41,257 beneficiaries have been paid. Under PMMVY, beneficiaries receive incentives of 5,000 rupees after the birth of the first child. A entitlement be availed if second can the second child is a girl.
