In response to the recent surge in child abuse cases across Nagaland, the State Commission for Protection of Child Rights has issued an advisory urging strict vigilance and legal action to ensure the protection of child rights. The advisory emphasizes that any form of child abuse regardless of the perpetrator, including parents or guardians is a serious offence and must be reported to the concerned authorities. Citizens are reminded that safeguarding children is a collective responsibility, and no case should be resolved through compromise, as this undermines justice and emboldens offenders. The Commission warned that offences under the POCSO Act, 2012, are non-bailable and cannot be settled privately. It also cautioned against taking the law into one's own hands and advised media and social media platforms to maintain ethical standards by protecting the identities of child victims. The Commission urged all to report any instance of child abuse immediately to the Child Helpline 1098, Special Juvenile Police Unit, District Child Protection Unit, Child Welfare Committee or the nearest police station. Reaffirming its commitment, the Commission stated it will continue to monitor all cases closely to ensure swift justice.



Member of Parliament Rajya Sabha, S. Phangnon Konyak, emphasised that as a tribal society, it is essential to uphold and safeguard one's identity particularly language, which serves as a fundamental means of communication. Ms. Konyak made this statement while releasing the book "A Descriptive Grammar of Konyak Language" yesterday in Mon. She said that the Nagas have passed down their heritage through oral history, and now the younger generation and new scholars are helping turn that into written records. Ms. Konyak also encouraged the youth to develop an interest in reading and writing in the Konyak language and to take up research to connect their ancestral past with written history. She hoped the book would help preserve the mother tongue and bring the Konyak Naga community closer together. The book, authored by Prof. Pangersenla Walling and Research Scholar Ms. Nikay Besa, is a joint effort by the Department of Linguistics, Nagaland University, and the Konyak Literature Board, with support from the Konyak Union, Mon HQ.



Advisor for Municipal Affairs & Urban Development, Zhaleo Rio said, Pradhan Mantri Awas Yojana, PMAY (Urban) has played a crucial role in realising the dream of Housing for all.
