Justice B R Gavai succeeded Justice Sanjiv Khanna, who demitted office yesterday. Vice President Jagdeep Dhankhar, Prime Minister Narendra Modi, several Union Ministers, and judges of the Supreme Court attended the ceremony, among others.

Nagaland state is setting up an enforcement directorate to strengthen implementation of the Inner Line Permit (ILP) system. Speaking to media persons post-cabinet in Kohima today, Minister for Power and Parliamentary Affairs, KG Kenye, said the proposed directorate will be constituted by officials and task forces from various departments and will work as a multi-tiered unit alongside the police and administration. He informed that police and administration have been directed to step up ILP enforcement. Mr Kenye said the Cabinet discussed the need to streamline ILP mechanisms, especially in light of the Citizenship Amendment Act and the National Register of Citizens.

Mr Kenye informed that the government will study digital ILP systems in other states to adopt best practices like online tracking, alerts, and payments. The proposal will then be examined by a subcommittee before being presented in the next Cabinet meeting.



Nagaland government has transitioned the Inner Line Permit (ILP) system to an online platform since the 1st of January this year. This digital process aims to streamline the application process, enhance efficiency and improve accessibility for the benefit of the general public. Minister for Power and Parliamentary Affairs, KG Kenye, today criticised NHIDCL for undue delays in the NH-29 road project. He said the government stands with the people. His remarks come amid the ongoing agitation by the Chakhesang Students' Union, which has imposed an indefinite ban on all vehicular movement involving NHIDCL, contractor Ratna Infra Projects Pvt. Ltd., and government vehicles, over unmet demands on the Chakhabama–Kikruma stretch (Package 2). Mr Kenye said the government has taken up the issue and expressed hope for an amicable resolution. On the CNCCI's call for a voluntary shutdown in nine districts from May 19, the minister termed the demands genuine but urged trade bodies not to resort to shutdowns. He said the new Nagaland Municipal Act, is still a "skeleton" and will be built upon. Regarding job reservation, Mr Kenye said the state government will wait for fresh Census data before considering any review. The minister appealed for public patience and understanding as the government works through these issues.

And, President Droupadi Murmu has appointed Dr. Ajay Kumar as the Chairman of the Union Public Service Commission. According to an Order issued by the Department of Personnel and Training, Dr. Kumar's tenure will begin on the day he assumes charge as Chairman of the UPSC. Dr. Kumar is a retired Indian Administrative Service officer from the 1985 batch of the Kerala cadre. He previously served as the Defence Secretary from August 2019 to October 2022.
