The Chümoukedima District Village Councils' Association (CDVCA) has called for an urgent review and amendment of the Ceasefire Ground Rules, citing increasing violations including the misuse of designated camps, open display of arms in public, and other activities that have led to fear and insecurity among civilians. In a representation submitted to the Chairman of the Ceasefire Monitoring Group (CFMG), the CDVCA comprising all village councils within Chümoukedima district, expressed deep concern over what it described as the deteriorating law and order situation resulting from the lax enforcement of the ceasefire framework. The Association highlighted that designated camps of the Naga Political Groups, which are under ceasefire agreements with the Government of India, are allegedly being misused. It further pointed to the visible movement of armed cadres in public spaces, which directly violates ceasefire protocols and creates an atmosphere of intimidation. The CDVCA also raised strong objections to the continued provision of security cover to leaders of various NPG factions, calling it contradictory to the principles of neutrality and peace. It demanded a complete ban on recruitment activities by the NPGs, asserting that such actions undermine the peace process and destabilize village communities.

India yesterday successfully test fired Intermediate Range Ballistic Missile 'Agni 5' from the Integrated Test Range in Chandipur, off the Odisha coast. In a statement, the Defence Ministry informed that the launch validated all operational and technical parameters. It added that the launch was carried out under the aegis of the Strategic Forces Command.

The entrance examination for admission to class VIII at the Rashtriya Indian Military College (RIMC) in Dehradun for July 2026 term will be held on December 7, 2025. Informing this, Nagaland Directorate of School Education (DoSE) said, the entrance test is open to both male and female candidates. The date for the interview will be intimated at a later date only for those candidates who qualify in the written exam. Prospectus cum Application Form and booklet of old question papers can be obtained by making online payment at admission.schoolmitra.com or via speed post by sending a self-addressed slip and a demand draft of 600 rupees for general candidates or 555 rupees for SC/ST candidate. Application on prescribed format accompanied along with the required documents should be submitted to the Directorate of School Education by 15th of October.

The Employees' Provident Fund Organization (EPFO) has recorded all time highest net addition of 21.89 lakh members during the month of June this year. The figure represents an increase

of 9.14 per cent, marking the highest recorded addition since payroll data tracking began in April 2018. In a statement, Ministry of Labour and Employment informed that around 10 lakh 62 thousand new subscribers have been enrolled in this month, representing a 12.68 per cent increase over May 2025 and a growth of 3.61 per cent compared to June previous year. The Ministry stated that around 6 lakh 39 thousand new subscribers were added in the 18-25 age group.
