GST Bachat Utsav, which was announced by Prime Minister Narendra Modi, and commenced on 22nd of last month, is benefiting all sections of society. Today, our correspondent brings a report on the GST reforms that will boost the economy of the state of Manipur.

GST V/C- The new GST reform is providing a major boost to Manipur's artisans, farmers, and small businesses. Hand-woven textiles, bamboo crafts, cane furniture, and local artisan goods which earlier attracted 12 percent GST are now being taxed at just 5 percent, giving artisans an opportunity to expand markets and improve incomes. Similarly, the significant reduction in taxes from 12 percent to 5 percent on processed food items such as pickles, bamboo shoots, fermented foods, vegetable preparations marks a major boost for producers and consumers as it increases affordability and market reach. Along with this, the tax cut on packaged coffee from 18 percent to 5 percent brings substantial relief across Manipur's coffee industry. With this move, districts such as Ukhrul, Senapati, and Chandel which are important hubs for coffee cultivation are being benefited as sector generates additional employment in processing, packaging, and distribution networks.

Ahead of the three-day pen-down strike from October 14, the Joint Coordination Committee (on IAS Induction) has directed all employees to maintain attendance at their workplaces and follow official protocols during the protest. The committee said, emergency and essential services will remain unaffected throughout the strike and urged all associations to ensure that the general public does not face inconvenience. The Joint Coordination Committee
