The final-day sessions of the Nagaland Cooperative Conclave focused on youth engagement, entrepreneurship, and strengthening the state's cooperative sector. Addressing the closing event in Kohima last evening, Commissioner & Secretary, Cooperation and Information & Public Relations, Orenthung Lotha, highlighted the growing importance of cooperatives in strengthening community resilience and driving inclusive economic growth. He said, the three-day conclave created a platform for participants to share ideas, experiences, and aspirations that reaffirm the potential of cooperatives beyond their role as institutions. Mr. Lothaemphasized that the discussions and activities had demonstrated how collective effort can help communities move markets, improve livelihoods, and contribute to the economic future of both Nagaland and the wider region. He expressed confidence that the partnerships formed during the event would continue to support farmers, artisans, entrepreneurs, youth, and communities across the state. Speaking on the occasion, Joint Registrar of Cooperative Societies, Bokato Hesso said, the cooperative movement in Nagaland is at a crucial turning point and needs stronger coordination, inclusive planning, and long-term strategies. Mr. Hesso stressed the need for better credit access, financial literacy, and improved utilization of resources, along with greater involvement of youth in emerging areas like climate-resilient farming and digital agriculture.



The Supreme Court has held that the Court cannot impose any timelines for decisions of the President and the Governor on granting assent to Bills under the Constitution. The Apex Court pronounced its opinion advisory on whether it can impose timelines on the President and State Governors for acting on Bills passed by State Legislatures. A Constitutional bench led by Chief Justice BR Gavai issued its opinion while answering 13 questions referred to it by President Droupadi Murmu under Article 143 of the Constitution, pertinently, whether timelines can be fixed for the Governor and the President to grant assent to State Bills.

The Chakhesang Students' Union has urged the National Highways and Infrastructure Development Corporation Limited, (NHIDCL) to take urgent corrective action over the grave public hardship caused by prolonged negligence in the execution of National Highway-29 along the Chakhabama–Kikrüma stretch.In a letter addressed to the Executive Director of NHIDCL's Regional Office in Kohima yesterday, the Union acknowledged the recent resolution of the Project Monitoring Group meeting held on November 14, 2025, which approved the termination of the existing contract for the project. However, the Union expressed concern over continued negligible progress and recurring inconsistencies, with the contractor failing to maintain the road even though the terrain requires year-round attention. Citing RTI findings, the Union noted that the project recorded only 25.70 percent physical progress and 25.41 percent financial progress, with expenditure exceeding actual work completed on the ground. The Union further called for immediate intervention and appealed to the concerned authorities to ensure timely completion of the crucial road project to restore public confidence.



In Wokha, a major fire broke out at PWD Colony yesterday, completely destroying a kuccha house and injuring a firefighter during the operation. Fire Station Officer-in-Charge, Francis Singsit said a team led by SI Thenuosielie Pielie was dispatched immediately after receiving the emergency call. He said, by the time firefighters arrived, the house was already engulfed, and two LPG cylinders had exploded, intensifying the blaze. Livestock on the premises were also burnt. A short circuit is suspected to have triggered the fire.
