Prime Minister Narendra Modi has called upon the States to encourage manufacturing, boost 'Ease of Doing Business' and make India a Global Services Giant. Mr Modi said that soon India would be launching the National Manufacturing Mission (NMM) and every State must give this top priority and create infrastructure to attract global companies. The Prime Minister said this while addressing the fifth National Conference of Chief Secretaries in New Delhi, which concluded yesterday. The three-day Conference began on the 26th of this month on the theme of Human Capital for Viksit Bharat. The Prime Minister said that India has boarded the "Reform Express", driven primarily by the strength of its young population, and empowering this demographic remains the government's key priority. Emphasising quality in governance, service delivery and manufacturing, he stated that the label "Made in India' must become a symbol of excellence and global competitiveness. He urged the Centre and States to jointly identify 100 products for domestic manufacturing to reduce import dependence and strengthen economic resilience in line with the vision of Viksit Bharat. Prime Minister Modi said that every State must create 10-year actionable plans based on the discussions of this Conference with 1, 2, 5 and 10 target timelines wherein technology can be utilised for regular monitoring.

The government has refuted a video falsely accusing that a large portion of the allocated funds for various government schemes remains unspent. According to the Fact Check unit of the Press Information Bureau, the claim is completely false as funds allocated for Centrally Sponsored Schemes have been largely utilised over the years. Furthermore, detailed expenditure records are regularly maintained. It urged the Citizens to remain cautious and not to trust unverified claims circulating on social media.

In 2025, India marked a decisive consolidation of its national security framework under the leadership of Prime Minister Narendra Modi. During the year, the government clearly articulated five firm norms on terrorism. These are - strong response to terror attacks, zero tolerance for nuclear blackmail, no distinction between terrorists and their sponsors, terrorism first in any dialogue, and an uncompromising stand on sovereignty. This resolve was most clearly demonstrated through Operation Sindoor. On the 7th of May, India carried out its most significant military strikes in over five decades in response to the Pahalgam terror attack. The operation drew global attention for its heavy reliance on indigenous capabilities. BrahMos supersonic missiles, Rafale fighter jets, and loitering drones were used in coordinated precision strikes, showcasing India's growing technological strength. Alongside operational resolve, India's defence capabilities witnessed unprecedented growth. Defence production crossed one lakh fifty-four thousand crore rupees, while the defence budget rose to over six lakh eighty-one thousand crore rupees for 2025-26. During the year, defence acquisitions worth over four lakh thirty thousand crore rupees were approved, including attack helicopters, Rafale-M jets for the Navy, advanced torpedoes, and surveillance systems. The year also saw major indigenous breakthroughs, from the commissioning of warships and submarines and the induction of stealth frigates, to the successful rail-based launch test of the Agni Prime missile and the rollout of Made-in-India AK-203 rifles. As the year concludes, India projects a framework of preparedness, technological confidence, and strengthened deterrence, reinforcing its commitment to national security and strategic self-reliance.
