Railways Minister Ashwini Vaishnaw yesterday announced that India is likely to receive its first Bullet Train on 15th of August 2027. Replying to a query during media briefing in New Delhi, Mr Vaishnaw said India's first bullet train project between Ahmedabad and Mumbai is under construction. He added that the first section to open will be from Surat to Bilimora followed by the section from Vapi to Surat.

Railways Minister also announced that the country's first Vande Bharat sleeper train will operate between Guwahati and Kolkata soon. Mr Vaishnaw said that Prime Minister Narendra Modi will inaugurate this train within the next 15 to 20 days.

Prime Minister Narendra Modi will inaugurate the Grand International Exposition of Sacred Piprahwa Relics related to Lord Buddha today at the Rai Pithora Cultural Complex in New Delhi. Union Minister for Chemicals and Fertilizers JP Nadda has inaugurated the e-Bill System that will enable the government to process the fertilizer subsidies amounting to approximately 2 lakh crore rupees. The newly launched system represents a paradigm shift from manual, paper-based processes to a fully digital, system-to-system workflow, eliminating the need for any physical movement of bills.

Ministry of Petroleum and Natural Gas has clarified that there has been no change in domestic LPG prices for household consumers. The clarification came following reports in some sections of the media that the price of commercial LPG cylinders has been increased by 111 rupees. The Ministry said that the price of commercial LPG cylinders is market-determined and linked to international benchmarks.

National Highways Authority of India yesterday announced discontinuation of the Know Your Vehicle (KYV) cards for cars for all new FASTag issuances with effect from 1st of the next month. The Ministry of Road Transport and Highways said the step has been taken to enhance public convenience and eliminate post-activation harassment faced by highway users. It added that KYV will be required only in specific cases where complaints are received and in the absence of any complaint, no KYV will be required for existing car FASTags.
